The algorithm in STAutoTables intelligently processes full-page OCR data. With minimal configuration to define columns to be captured - header label information and expected formats of the column data, STAutoTables parses out data into rows and columns. STAutoTablesDesigner is the user-interface that allows configuration of basic rules for capture of table data.

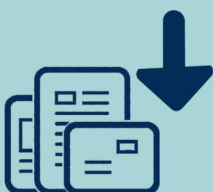
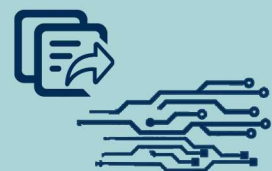

USE CASE / SCENARIO

When Extraction module is employed to extract data from multi-table documents such as brokerage tax statements, transcripts, invoices, datasheets, Remittance Advices or Explanation of benefits, due to the semi-structured nature of the documents, the software is unable to determine the start & end of the tables without heavy configuration. The column headings may slightly differ resulting in a huge number of templates to handle the variations.

Some lines of business have multiple tables with unique column headings and row constraints. In many such tables, there are secondary rows that need to be ignored or sometimes merged with the primary rows. Totals and sub-totals may appear on the rows that may need to be ignored or be used for computation purposes.
